Only those papers will be accepted which have not yet been published in German. Papers which have already been published by other technical journals cannot be taken into consideration. Unsolicited manuscripts cannot be guaranteed.

Lay-Out of Manuscripts

The manuscripts for the sections “Technics”, “Medicine” and “Science” (specialist articles) should not contain more than 8 typed DIN A 4 pages at line spacing 1 1/2 excluding illustrations, abstracts and bibliographical references. If the manuscript exceeds these limits the editors or the scientific advisor, respectively, principally reserve the right of abridgements to themselves.

Manuscripts which shall be published as short reports may not contain more than 3 typed pages.

Each article has to be provided with a short **abstract**. Short reports are published without abstracts.

Bibliographical References

Books, journal articles etc. have to be indicated in the text by consecutive numbers in square brackets [1]. Sources quoted in the text have to be mentioned completely in the bibliographical references at the end of the text.

The bibliographical references have to be written on an extra page of the manuscript, ordered by mounting numbers and in alphabetical order. Each reference must contain:

1. For books: name of the author, abbreviations of the christian name(s), title of the book, volume (only if there are several volumes), edition, place of publication, publishing house, year of publication.

Example: Pitzen, P., H. Rössler: Kurzgefaßtes Lehrbuch der Orthopädie, 11. Auflage, München, Urban und Schwarzenberg, 1970

2. For journal articles the procedure is similar:

Example: Volkert, R., W. Schön: Individuelle orthopädie-technische Hilfsmittel zur funktionellen Verbesserung der behinderten Hand, Orthopädie-Technik 29 (1978), 13 - 16

Illustrations, charts

Illustrations and charts have to be numbered consecutively, to be quoted at the right places of the text (i. e. fig. 1 ...chart 1 ...) **and to be provided with explanatory captions**. Charts should be done in a way that they could be scaled down. Most apt for reproduction are black and white glossy prints or clean pen-and-ink drawings. For better identification it is useful to indicate the name of the author and the number of the photo on its back.

Please supply electronic graphic data separately in a saving density of at least 300 dpi as a non-compressed original graphic format like TIFF or EPS or as JPG. Graphic data (photos, drawings, also charts) which have been embedded in Microsoft Word or in Powerpoint charts are of considerably reduced quality and can be processed for magazine printing only with many difficulties and a loss of quality.

Proofs/Reprints and Special Prints

The author mentioned in the first place (or the author who has done the correspondence up to then) will be provided with a copy of the makeup for printing release. Because of the process of journal production we regret that there is usually only a short interval for the author to correct the text. For the same reasons, the printing release is given directly to the printer's. The publishing house and the printer's are through this licence relieved of any responsibility for possible discrepancies.

Reprints (cost-free, also contain other editorial articles or advertisements) and special prints (please ask for prices, which depend on copies published, at the publishing house) with a special title page can be ordered at the publishing house.
